##### **Regular Membership**

Any privately owned company authorized to, and actively engaged in, the transport of passengers for hire in non-school transportation vehicles designed to seat more than 15 passengers without wheelchairs or 6 passengers with wheelchairs may become a voting member of the Association provided the company is under the supervision and jurisdiction of, and has received operating authority from, the NYSDOT and/or the FMCSA or their successor agencies. Such company must operate a significant portion of its passenger transportation business either inside or to/from the State of New York. A Regular Bus Operator Member agrees to pay annual dues in **one** of the following categories based on your fleet size:

Number of Vehicles	Membership Cost	Suggested PAC Contribution
1-5	\$250	\$50
6-15	\$500	\$150
16-30	\$1000	\$250
31-49	\$2000	\$500
50 or more	\$4000	\$1000
